

Appendix B1 – Championship Winner – Driver

Bet Type	Championship Winner – Driver
Bet Event	A particular race season (“the Championship”)
Selections	Selected by the Company from drivers participating in the Championship
Result	The winner of the Championship.
Special Provisions	Bets will not be refunded if the driver picked by the Participant participates in, but for any reason does not complete or finish the Championship.

Appendix B2 – Championship Winner – Team

Bet Type	Championship Winner – Team
Bet Event	A particular race season (“the Championship”)
Selections	Selected by the Company from teams participating in the Championship
Result	The winning team of the Championship.
Special Provisions	Bets will not be refunded if the team picked by the Participant participates in, but for any reason does not complete or finish, the Championship.

Appendix B3 – Race Winner – Driver

Bet Type	Race Winner – Driver
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the race
Result	The winner of the race.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply.

Appendix B4 – Race Winner – Team

Bet Type	Race Winner – Team
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from teams participating in the race
Result	The team with the winning driver of the race.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply.

Appendix B5 – To Qualify in Pole

Bet Type	To Qualify in Pole
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the qualifying session(s)
Result	Driver who is announced as qualifying in pole position immediately following the end of the qualifying session(s), regardless of any subsequent protests, disqualifications, corrections or amendments to placings or results.
Special Provisions	All bets placed on a driver who competes in the qualifying session(s) shall stand, even if the driver fails to set a time.

Appendix B6 – Fastest Lap

Bet Type	Fastest Lap
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the race
Result	The driver who records the fastest lap in the race.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply. Disqualified drivers are deemed non-winning selections.

Appendix B7 – Number of Classified Drivers

Bet Type	Number of Classified Drivers
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Three possible selections: - Below X - Between X and Y inclusive - Above Y where X and Y denotes the number of Classified drivers
Result	The selection corresponding to the number of Classified drivers in the race.
Special Provisions	Disqualified drivers are deemed non-Classified.

Appendix B8 – Winning Margin

Bet Type	Winning Margin
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Three possible selections: - Under X - Between X and Y inclusive - Over Y where X and Y denotes time in seconds
Result	The selection corresponding to the Winning Margin in the race.
Special Provisions	"Winning Margin" means the time difference between the drivers who finish the race in 1st and 2nd positions respectively.

Appendix B9 – Dual Forecast

Bet Type	Dual Forecast
Bet Event	A particular Event arising in a race corresponding to an Event Number.
Selections	Possible Selections: - Pairs of two named drivers selected by the company. - Any other pairing of two drivers (Any Other Combination "AOC")
Result	The selection where both drivers finish in the top two positions.
Special Provisions	Dead Heat provisions in the Motor Racing Rules apply. Bets on a pair of named drivers will be void and refunded if at least one of the named drivers in that pair is a non-runner. Bets on Any Other Combination ("AOC") will be refunded if all selections of named drivers are void.

Appendix B10 – Trio

Bet Type	Trio
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Possible Selections: - Combinations of three named drivers selected by the company. - Any other combination of three drivers (Any Other Combination “AOC”)
Result	The selection where all three drivers finish in the top three positions.
Special Provisions	Dead Heat provisions in the Motor Racing Rules apply. Bets on a combination of named drivers will be void and refunded if at least one of the named drivers in that combination is a non-runner. Bets on Any Other Combination (“AOC”) will be refunded if all selections of named drivers are void.

Appendix B11 – Top 3

Bet Type	Top 3
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the race
Result	Drivers who finish in the top three positions.
Special Provisions	Dead Heat provisions in the Motor Racing Rules apply. Disqualified, non-classified and retired drivers are deemed non-winning selections.

Appendix B12 – Top 8

Bet Type	Top 8
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the race
Result	Drivers who finish in the top eight positions.
Special Provisions	<p>Dead Heat provisions in Motor Racing Rules apply.</p> <p>Disqualified, non-classified and retired drivers are deemed non-winning selections.</p> <p>Bets will be void and refunded if the number of runners in the race is 15 or fewer.</p>

Appendix B13 – Top Score Team

Bet Type	Top Score Team
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from teams participating in the race
Result	The team with the highest combined points of both drivers in the same team.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply.

Appendix B14 – Head-to-Head Driver

Bet Type	Head-to-Head Driver
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	A pair of drivers selected by the Company from drivers participating in the race
Result	The driver with the higher finishing position in the race, or, the driver who completes the most laps.
Special Provisions	<p>Bets will be void and refunded if:</p> <ul style="list-style-type: none"> i) at least one of the selected drivers is deemed as a non-runner; ii) both drivers retire on the same lap; or iii) both drivers are disqualified during the race.

Appendix B15 – Head-to-Head Team

Bet Type	Head-to-Head Team
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	A pair of teams selected by the Company from teams participating in the race
Result	The team with the better classified driver.
Special Provisions	<p>Bets will be void and refunded if both drivers from at least one of the two teams are deemed as non-runners.</p> <p>Bets will be void and refunded if both teams have no Classified drivers.</p> <p>Disqualified drivers are deemed non-Classified.</p>

Appendix B16 – Best of the Rest – Driver

Bet Type	Best of the Rest – Driver
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Drivers selected by the Company from drivers participating in the race
Result	The best placed driver in the race among the listed selections.
Special Provisions	Disqualified Drivers are deemed non-winning selections. Dead Heat provisions in Motor Racing Rules apply.

Appendix B17 – Best of the Rest - Team

Bet Type	Best of the Rest – Team
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Teams selected by the Company from teams participating in the race
Result	The Team with the best placed driver.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply.

Appendix B18 – Will the Driver be in the Top 3?

Bet Type	Will the Driver be in the Top 3
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Driver selected by the Company. There are two possible selections: - Yes - No
Result	The Result shall be “Yes” if the selected Driver finishes in 1st, 2nd or 3rd position in the race. The Result shall be “No” if the selected Driver does not finish in 1st, 2nd or 3rd position, has retired or is disqualified.
Special Provisions	Bets will be void and refunded if the selected Driver is a non-runner.

Appendix B19 – Will the Driver be in the Top 8?

Bet Type	Will the Driver be in the Top 8
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Driver selected by the Company. There are two possible selections: - Yes - No
Result	The Result shall be “Yes” if the selected Driver finishes in one of the top eight positions in the race. The Result shall be “No” if the selected Driver does not finish in one of the top eight positions, has retired or is disqualified.
Special Provisions	Bets will be void and refunded if the selected Driver is a non-runner or the number of runners is 15 or fewer.

Appendix B20 – Will the Driver be Classified?

Bet Type	Will the Driver be Classified
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Driver selected by the Company. There are two possible selections: - Yes - No
Result	The Result shall be “Yes” if the selected Driver is Classified. The Result shall be “No” if the selected Driver is not Classified, or is disqualified.
Special Provisions	Bets will be void and refunded if the selected Driver is a non-runner.

Appendix B21 – Number of Classified Drivers (Odd/Even)

Bet Type	Number of Classified Drivers Odd/Even
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	- Odd - Even
Result	The Result shall be “Odd” if the total number of Classified drivers is an odd number. The Result shall be “Even” if the total number of Classified drivers is an even number.
Special Provisions	Disqualified drivers shall be deemed as non-Classified.

Appendix B22 – First to Retire – Driver

Bet Type	First to Retire – Driver
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from drivers participating in the race
Result	The driver that completes the least number of laps in the race, including Formation Lap.
Special Provisions	Dead Heat provisions in Motor Racing Rules apply if more than one driver completes the same least number of laps. Bets will be void and refunded if there is no Retirement in the race.

Appendix B23 – First to Retire - Team

Bet Type	First to Retire – Team
Bet Event	A particular Event arising in a race corresponding to an Event Number
Selections	Selected by the Company from teams participating in the race
Result	The team of the driver that completes the least number of laps in the race, including Formation Lap.
Special Provisions	<p>Dead Heat provisions in Motor Racing Rules apply if more than one driver completes the same least number of laps.</p> <p>Bets will be void and refunded if there is no Retirement in the race.</p>
