# GAME RULES FOR THE TOTO GAME ("TOTO GAME RULES")

The following Rules are laid down by Singapore Pools (Private) Limited ("Singapore Pools", "we", "us" or "our") for the TOTO Game.

# 1. Objective

1.1 The TOTO Game is a six (6) out of forty-nine (49) lotto game with one (1) additional number, from 1 to 49 (both numbers inclusive) where you purchase a lottery ticket for a betting selection made under a selected bet type offered by Singapore Pools for a particular draw. A lottery ticket includes both physical tickets issued offline for bets placed in person, as well as digital records and e-tickets issued for bets placed remotely. To qualify for a winning prize, your selected number(s) or outcome on your lottery ticket must match the winning numbers drawn during the particular draw (including the Additional Number<sup>1</sup>, where applicable) or which your lottery ticket is valid.

# 2. How to Play

- 2.1 For every particular draw of the TOTO Game, Singapore Pools shall first draw six (6) different numbers out of forty-nine (49) numbers from 1 to 49 (both numbers inclusive). After these six (6) numbers are drawn, Singapore Pools shall draw one (1) more number from the remaining forty-three (43) numbers (the "Additional Number"). The six (6) numbers drawn together with the Additional Number shall constitute the winning numbers for the particular draw of the TOTO Game (the "Winning Numbers").
- 2.2 To play the TOTO Game, you are essentially placing a bet on six (6) different numbers out of forty-nine (49) numbers from 1 to 49 (both numbers inclusive). In order to win a prize in the TOTO Game, your selected set(s) of six numbers must minimally contain at least three (3) of the Winning Numbers (excluding the Additional Number). Please refer to the prize structure for the TOTO Game as set out at Clause 5.5 of this TOTO Game Rules below.

# i. Types of Entry

2.3 To participate in the TOTO Game, you are required to place a wager or what is otherwise referred to as an "**Entry**". There are eight different types of Entries that you may purchase to participate in the TOTO Game:

Ordinary Entry: Purchase of a wager on a selected set of six (6) numbers from one (1) to forty-nine (49) (both numbers inclusive).

> Example: You place a bet on "3", "8", "14", "21", "22" and "26". You will win only if at least 3 of the Winning Numbers (excluding the Additional Number) drawn are "3", "8", "14", "21", "22" or "26".

System Roll **Entry:** 

Purchase of a wager on forty-four (44) possible combinations, by selecting only five (5) numbers with the last number being a rolling number.

Example: You select the 5 digits "3", "8", "14", "21" and "22". Your wager essentially consists of 44 combinations of [3, 8, 14, 21, 22, R] where R is any number from 1 to 49 excluding 3, 8, 14, 21 and 22.

**System 7 Entry:** Purchase of a wager on all possible combinations of sets of six (6) numbers from a selection of seven (7) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on seven (7) possible combinations in a System 7 Entry.

> Example: You select the seven (7) digits "3", "8", "14", "21", "22", "26" and "34". You are placing a bet on all the possible sets of six (6) numbers from these seven (7) numbers, i.e.:

- a) [3, 8, 14, 21, 22, 26]
- b) [3, 8, 14, 21, 22, 34]
- c) [3, 8, 14, 21, 26, 34]
- d) [3, 8, 14, 22, 26, 34]
- e) [3, 8, 21, 22, 26, 34]
- f) [3, 14, 21, 22, 26, 34]
- g) [8, 14, 21, 22, 26, 34]

**System 8 Entry:** 

Purchase of a wager on all possible combinations of sets of six (6) numbers from a selection of eight (8) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on twentyeight (28) possible combinations in a System 8 Entry.

Example: You select the eight (8) digits "3", "8", "14", "21", "22", "26", "34" and "39". You are placing a bet on all the possible sets of 6 numbers from these eight (8) numbers.

**System 9 Entry:** 

Purchase of a wager on all possible combinations of sets of (six) 6 numbers from a selection of nine (9) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on eighty-four (84) possible combinations in a System 9 Entry.

Example: You select the nine (9) digits "3", "8", "14", "21", "22", "26", "34", "39" and "40". You are placing a bet on all the possible sets of six (6) numbers from these nine (9) numbers.

**System 10 Entry:** 

Purchase of a wager on all possible combinations of sets of six (6) numbers from a selection of ten (10) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on two hundred and ten (210) possible combinations in a System 10 Entry.

Example: You select the ten (10) digits "3", "8", "14", "21", "22", "26", "34", "39", "40" and "45". You are placing a bet on all the possible sets of six (6) numbers from these ten (10) numbers.

System 11 Entry:

Purchase of a wager on all possible combinations of sets of six (6) numbers from a selection of eleven (11) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on four hundred and sixty-two (462) possible combinations in a System 11 Entry.

Example: You select the eleven (11) digits "3", "8", "14", "21", "22", "26", "34", "39", "40", "45" and "47". You are placing a bet on all the possible sets of six (6) numbers from these eleven (11) numbers.

**System 12 Entry:** 

Purchase of a wager on all possible combinations of sets of six (6) numbers from a selection of twelve (12) numbers from one (1) to forty-nine (49) (both numbers inclusive). You are placing a bet on nine hundred and twenty-four (924) possible combinations in a System 12 Entry.

Example: You select the twelve (12) digits "3", "8", "14", "21", "22", "26", "34", "39", "40", "45", "47" and "49". You are placing a bet on all the possible sets of six (6) numbers from these twelve (12) digits.

- 2.4 For each Entry, you are required to select numbers to form set(s) of at least six (6) numbers. You may choose to select these numbers yourself, or allow the numbers to be selected randomly by Singapore Pools' computer system (otherwise known as the "Quick Pick" option). All selected numbers (whether selected by you or randomly generated through the Quick Pick option) will be recorded on Singapore Pools' lottery bet engine ("LB Engine"). For all bets placed through your verified account opened with Singapore Pools for the purpose of remote betting ("Remote Betting Account") via the Singapore Pools website and mobile app, you may access records of these bets through the Singapore Pools website and mobile app for a period of 6 months from the date of your transaction.
- 2.5 Singapore Pools shall, from time to time and at our sole and absolute discretion, determine the types of Entry that are available for your participation in the TOTO Game.

# ii. Modes of Play

- 2.6 Group TOTO and iTOTO are two modes of play through which you may participate in the TOTO Game.
  - a) **Group TOTO:** By making an Entry through Group TOTO, you are requesting us to divide your Entry into a specified number of equal units, up to a maximum of ten (10) units. Your Entry is treated as a single bet in our system regardless of how many units the Entry is divided into, and you will receive the number of lottery tickets equal to the number of units that the Entry is divided into as you have requested. Each lottery ticket for the Group TOTO Entry will indicate the type of Entry (e.g. Ordinary Entry), the amount you are wagering for each Entry (otherwise known as the "**stake**") and the unit number of the lottery tickets. The total stake paid for the Group TOTO Entry will be divided equally amongst the issued lottery tickets, and the amount per unit after division must be in multiples of ten (10) cents and shall be no less than seven (7) Singapore dollars per unit. Should your Group TOTO Entry win a prize, the prize amount will be divided equally by the number of issued lottery tickets and the bearer of each lottery ticket can claim a proportion of the prize amount for the Group TOTO Entry based on his or her lottery ticket.

For example: if you purchase a System 7 Entry for 4 draws and split this into four (4) units, we will issue four (4) lottery tickets containing one (1) set of seven (7) numbers. The total stake is S\$28 (4 draws x \$7), and the amount per unit is S\$7. If the bet wins a prize of S\$210,000, the bearer of each of the four (4) lottery tickets will win S\$52,500.

b) **iTOTO**: In an iTOTO Entry, Singapore Pools makes available a number of units of a System Roll Entry/System 7 Entry/System 8 Entry/System 9 Entry/System 10 Entry/System 11 Entry/System 12 Entry for individual participation. The number of units and the stake for each iTOTO Entry will be made known to you, and you will make payment only for the number of units which you wish to purchase. You will receive a lottery ticket indicating the type of Entry (e.g. System 12 Entry), the total stake, the total number of units created for the iTOTO Entry and the number of units which you have purchased. Should the iTOTO Entry win a prize, the prize

amount will be divided equally by the total number of units (both sold and unsold) and you will win a proportion of the prize amount based on the number of units you have purchased. Prize amounts due to winning Participants will remain unaffected by the existence or number of unsold iTOTO units. Instead, the prize amount due to each winning Participant is determined by the number of units which that winning Participant has purchased. Should there be any unsold iTOTO units that are part of a winning bet, the prize monies attributable to these winning unsold units will be channelled by Singapore Pools to good causes through the Singapore Totalisator Board.

2.7 You may make an Entry to consecutive draws for the TOTO Game. We shall have the full discretion on whether to permit you to make Entries to a consecutive number of draws of the TOTO Game, including how many such consecutive draws you are allowed to make an Entry to. These TOTO Game Rules shall apply to each consecutive Entry in respect of each consecutive draw entered.

# iii. TOTO Subscription

- 2.8 Singapore Pools may, at our sole and absolute discretion, make available the option for you to place your bet through the Singapore Pools website or mobile app for a particular Entry across ten (10) consecutive draws based on the selected numbers (whether such numbers are selected by yourself or through Quick Pick) ("TOTO Subscription") by such means or methods and upon such conditions which we deem fit, including but not limited to maximum limits on the number of TOTO Subscriptions which you may place and maintain and the maximum stake per draw.
- 2.9 As an example, for a TOTO Subscription where you subscribe for a certain number of self-pick System 7 bets, we will automatically place the same number of bets with identical sets of selected numbers on your behalf for ten (10) consecutive draws of the TOTO Game.

#### Illustration:

If you subscribe for two (2) self-pick System 7 bets, with Set A consisting of "1", "5", "17", "23", "32", "41" and "48" and Set B consisting of "3", "6", "12", "27", "38", "39" and "46", we will place one (1) self-pick System 7 bet for Set A and one (1) self-pick System 7 bet for Set B for ten (10) consecutive draws of the TOTO Game.

- 2.10 As an example, for a TOTO Subscription where you subscribe for a certain number of Quick Pick Ordinary Entry bets, we will automatically place the same number of Quick Pick Ordinary Entry bets on your behalf for 10 consecutive draws of the TOTO Game.
- 2.11 You may cancel your TOTO Subscription at any time through the Singapore Pools website or mobile app.

# 3. Placing your bets

- 3.1 You will be able to place your bets for the TOTO Game either (a) in person at our betting outlets or with our authorised retailers; or (b) remotely through our website and mobile app.
- 3.2 Singapore Pools has the full discretion to determine the maximum number of bets that you may place for each TOTO Game from time to time. At the time of placing your bets, you will only be able to place up to this determined maximum number of bets.
- 3.3 Singapore Pools has full discretion to determine from time to time, the maximum and minimum limits of the stake that you may place, as well as any other conditions attached to such stake as may be notified to you through the Singapore Pools website or mobile app.
- 3.4 The stake for each selected set of six (6) numbers for participation in the TOTO Game shall be one (1) Singapore dollar or multiples of one (1) Singapore dollar, inclusive of Goods and Services Tax (GST). The stake payable for every lottery ticket for the TOTO Game shall be no less than one (1) Singapore dollar, inclusive of GST.
- 3.5 The requisite stake payable for making a System Roll Entry, System 7 Entry, System 8 Entry, System 9 Entry, System 10 Entry, System 11 Entry and System 12 Entry are as follows:

- 3.6 Non-subscription TOTO bets may be placed from as early as fifteen (15) days up to half an hour before the conduct of the TOTO Game draw. If a bet is successfully placed at our betting outlets and authorised retailers, you will receive a lottery ticket, which will serve as proof that your bet has been validly placed. If a bet is successfully placed through your Remote Betting Account via the Singapore Pools website and mobile app, you will receive a confirmation that your bet has been successfully placed. The bet will be recorded in your Remote Betting Account, and such record will serve as proof that your bet has been validly placed.
- 3.7 For TOTO Subscription bets, the first bet under the TOTO Subscription will be automatically placed when sales open for the next draw of the TOTO Game. If your TOTO Subscription is made on a Tuesday, do note that your first bet will be placed for the draw on the coming Monday, and not the draw on the coming Thursday as

- sales would have already opened for the Thursday draw at the time your TOTO Subscription is made on Tuesday.
- 3.8 Your TOTO Subscription bets placed for each draw will be deemed to be valid and accepted by Singapore Pools only if full payment has been made for the requisite stake amount for your bet. If such full payment is not made, the bet will be invalid and rejected by Singapore Pools. Where funds in your account are insufficient to pay for the full number of bets subscribed for a particular draw of the TOTO Subscription, then no bets will be placed, but you will nonetheless be deemed to have been allowed to place bets on your selected numbers for that particular draw for purposes of your TOTO Subscription.

#### **Illustration:**

You have placed a TOTO Subscription for five (5) System 7 bets to be placed in ten (10) consecutive draws. For the sixth (6<sup>th</sup>) draw, you only have sufficient funds in your account to make payment for two (2) out of the five (5) System 7 bets. No bets will be placed for this particular TOTO draw, but you would be deemed to have used up your opportunity to place your five (5) System 7 bets for that particular draw, and you will thereafter have only four (4) remaining draws in your TOTO Subscription for you to place five (5) System 7 bets on your selected numbers per draw.

3.9 Although you may cancel your TOTO Subscription at any time, any bets that have been successfully placed cannot be cancelled.

# 4. Matching of Winning Numbers and Prize Money

- 4.1 The Winning Numbers of each TOTO Game Draw are determined in the manner stated at Clause 2.1 above. Singapore Pools will conduct the draws of the TOTO Game and shall have full discretion over the decision on how the Winning Numbers of each TOTO Game draw are to be decided.
- 4.2 Official information on the results of the relevant TOTO Game draw will be released by us on the Singapore Pools website and mobile app. Singapore Pools reserves the right to rectify any errors discovered after the official information has been released on our website and mobile app, and the results of the relevant draw (including the amounts of prizes declared for the draw) will be as stated in the latest rectified version. Otherwise, the results of the relevant draw (including the amounts of prizes for the draw) shall be as announced on the Singapore Pools website and mobile app at the end of the relevant draw.

#### 5. Prize Structure

5.1 The placement of bets by participants in the TOTO Game is processed, consolidated and recorded by Singapore Pools' LB Engine. For purposes of calculating the prize pool and the number of winning shares for a draw of the TOTO Game, Singapore Pools' records of bets for that draw of the TOTO Game as recorded by the LB Engine shall be conclusive of the total number of bets placed and the details of each bet placed for that draw. Such bets as recorded in the LB Engine may include bets in respect of which, due to technical issues, system failures or any other reason, the

relevant Stake has not been paid to or accepted by Singapore Pools ("**Unpaid Bets**"). We shall make up for any shortfall in the prize pool attributable to such Unpaid Bets. Where such Unpaid Bets constitute a winning combination, each of them shall, for purposes of calculating the prize pool and the number of winning shares for the relevant draw of the TOTO Game, be treated as a winning share in the Jackpot Prize or Group 2, 3 or 4 prize, or otherwise qualify for a prize in Group 5, 6 or 7. All prize monies attributable to such winning Unpaid Bets will be channelled by Singapore Pools to good causes through the Singapore Totalisator Board.

For the purposes of these TOTO Game Rules, a bet means a wager placed with Singapore Pools by a participant and recorded as such by the LB Engine, whether placed at our betting outlets or via the participant's remote betting account.

In order to win a prize in the TOTO Game, your selected set(s) of six numbers must minimally contain at least three (3) of the Winning Numbers (excluding the Additional Number) for the particular draw for which your lottery ticket is valid. Please refer to the prize structure for the TOTO Game as set out at Clause 5.5 of this TOTO Game Rules below.

#### **Illustration:**

Your lottery ticket has two sets of six (6) numbers. Set A consists of "1", "5", "17", "23", "32" and "41". Set B consists of "3", "6", "12", "27", "38" and "39". If the Winning Numbers are "1", "4", "5", "12", "17" and "41" with "32" as the Additional Number, you will win a prize with Set A but not Set B. If the Winning Numbers are "1", "12", "27", "28", "41" and "46" with "39" as the Additional Number, you will not win any prize.

5.3 The detailed prize structure is set out below at Clause 5.5.

#### A. Prize Pool and Prize Structure

- There is a prize pool available for the distribution of prizes which may be won for Prize Groups 1 to 4 for a particular draw of the TOTO Game ("**Prize Pool**"), and the Prize Pool shall be an amount equal to 54.5% of the net amount of the total stake collection of that particular draw less any GST thereon.
- 5.5 The prize structure for any draw of the TOTO Game, including the prize group, the number of Winning Numbers matched for a particular prize group and the prize amount for a particular prize group, is as described below:

- 5.6 We guarantee that the minimum prize amount for the Jackpot Prize for all draws of the TOTO Game shall always be \$1,000,000 at the minimum. In other words, if the Jackpot Prize for any particular draw falls below \$1,000,000, we will increase the prize amount for the Jackpot Prize to \$1,000,000. For the avoidance of doubt, there is no minimum guaranteed prize amount for Prize Group 2, Prize Group 3 and Prize Group 4.
- 5.7 Singapore Pools is entitled to, at our sole and absolute discretion, round up or down the prize amount payable to the nearest currency denomination or unit as it deems fit.
- 5.8 For the avoidance of doubt, each separate set of 6 numbers on your lottery ticket will be matched against the Winning Numbers. For example, if you purchase a System 7 Entry with the numbers "3", "8", "14", "21", "22", "26" and "34", you will have seven (7) separate sets of six (6) numbers as follows:-

Set A: [3, 8, 14, 21, 22, 26] Set B: [3, 8, 14, 21, 22, 34] Set C: [3, 8, 14, 21, 26, 34] Set D: [3, 8, 14, 22, 26, 34] Set E: [3, 8, 21, 22, 26, 34] Set F: [3, 14, 21, 22, 26, 34] Set G: [8, 14, 21, 22, 26, 34]

Each of these seven (7) sets of (6) numbers will be treated separately from the other, and will each be compared against the Winning Numbers and Additional Number to determine your winnings. So if the Winning Numbers are "7", "21", "22", "26",

"33" and "42" with an Additional Number of "14", your winnings will be as follows:-

Set A: Prize Group 6

Set B: No prize

Set C: No prize

Set D: No prize

Set E: Prize Group 7

Set F: Prize Group 6

Set G: Prize Group 6

5.9 For the further avoidance of doubt, each set of six (6) numbers will only entitle you to win <u>one (1)</u> prize. You will automatically be awarded the highest prize that your selected set of six (6) numbers is eligible for.

# i. Snowballing

5.10 A key feature of the TOTO Game is the carrying forward of the prize amount for the Jackpot Prize, Prize Group 2, Prize Group 3 and Prize Group 4 in the event that there are no winners for the particular prize group in a particular draw of the TOTO Game, a process which is otherwise known as "snowballing". This "snowballing" process occurs in the following manner:

**Jackpot Prize:** 

If there are no winners for the Jackpot Prize in a particular draw of the TOTO Game, the prize amount for the Jackpot Prize excluding the minimum guaranteed amount of \$1,000,000<sup>4</sup> shall be carried forward and added to the prize amount of the Jackpot Prize of the next draw of the TOTO Game. This "snowballing" shall continue until the Jackpot Prize is won or until the "cascading" process has been triggered (as described at Clause 5.12 below), i.e. at the end of four (4) consecutive draws of the TOTO Game or such number of consecutive draws which may be determined by Singapore Pools from time to time as being required to trigger the "cascading" process (see Clause 5.11 below).

**Group 2 Prize:** 

If there are no winners for the Group 2 Prize in a particular draw of the TOTO Game, the prize amount shall be carried forward and added to the prize amount of the Group 2 Prize of the next draw of the TOTO Game. This "snowballing" shall continue until the Group 2 Prize is won.

**Group 3 Prize:** 

If there are no winners for the Group 3 Prize in a particular draw of the TOTO Game, the prize amount shall be carried forward and added to the prize amount

of the Group 3 Prize of the next draw of the TOTO Game. This "snowballing" shall continue until the Group 3 Prize is won.

**Group 4 Prize:** 

If there are no winners for the Group 4 Prize in a particular draw of the TOTO Game, the prize amount shall be carried forward and added to the prize amount of the Group 4 Prize of the next draw of the TOTO Game. This "snowballing" shall continue until the Group 4 Prize is won.

5.11 Save where otherwise stipulated by Singapore Pools, the number of consecutive draws for the TOTO Game required to trigger the "cascading" process (as described at Clause 5.12 below) is four (4). Singapore Pools reserves the right to vary the number of consecutive draws required to trigger the "cascading" process from time to time at our sole and absolute discretion, subject to a maximum of four (4) consecutive draws required. The number of consecutive draws required to trigger the "cascading" process at any point in time will be as stated on the SPPL website.

# ii. Cascading

- 5.12 Another key feature of the TOTO Game is the "cascading" process which is triggered when the Jackpot Prize remains unwon at the end of a specified number of consecutive draws of the TOTO Game to be determined by Singapore Pools. In such an event, the prize amount of the unwon Jackpot Prize shall be paid in the following manner:
  - a) If the Jackpot Prize is not won at the end of the last consecutive draw of the TOTO Game required to trigger the cascading process, the Jackpot Prize shall be shared equally among the winning shares of the Group 2 Prize of the said last consecutive draw.
  - b) If there are no winners of the Group 2 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be shared equally among the winning shares of the Group 3 Prize of the aforesaid last consecutive draw.
  - c) If there are no winners of the Group 2 Prize and Group 3 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be shared equally among the winning shares of the Group 4 Prize of the aforesaid last consecutive draw.
  - d) If there are no winners of the Group 2 Prize, Group 3 Prize and Group 4 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be shared equally among the winning shares of the Group 5 Prize of the aforesaid last consecutive draw.
  - e) If there are no winners of the Group 2 Prize, Group 3 Prize, Group 4 Prize and Group 5 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be shared equally

among the winning shares of the Group 6 Prize of the aforesaid last consecutive draw

- f) If there are no winners of the Group 2 Prize, Group 3 Prize, Group 4 Prize, Group 5 Prize and Group 6 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be shared equally among the winning shares of the Group 7 Prize of the aforesaid last consecutive draw.
- g) If there are no winners of the Group 2 Prize, Group 3 Prize, Group 4 Prize, Group 5 Prize, Group 6 Prize and Group 7 Prize during the aforesaid last consecutive draw of the TOTO Game, the unwon Jackpot Prize shall be carried forward and added to the prize amount of the Jackpot Prize of the next draw of the TOTO Game. This shall reset the "cascading" process, i.e. "cascading" will next take place if the Jackpot Prize is unwon after the specified number of consecutive draws (inclusive of this draw).

Where the unwon Jackpot Prize is paid out pursuant to any of the above circumstances set out in (a) – (f) of this Clause 5.12, the winners for the Group 2 Prize, Group 3 Prize, Group 4 Prize, Group 5 Prize, Group 6 Prize or Group 7 Prize (as the case may be) shall also receive their respective share(s) of the prize amount set out in Clause 5.5 above.

# iii. Winning Shares / Prizes

- 5.13 There may be more than one person obtaining the winning combination of numbers for each prize group of the TOTO Game. For prizes in the Jackpot Prize, Prize Group 2, Prize Group 3 and Prize Group 4, each winning combination of numbers matching the requisite number of Winning Numbers set out in the Prize Structure for TOTO Game above shall be a winning share in the corresponding prize amount. The prize amounts of Jackpot Prize, Prize Group 2, Prize Group 3 and Prize Group 4 shall be shared equally among the total number of winning shares for the particular prize group.
- 5.14 If you have placed an Ordinary Entry and your selected set of six (6) numbers is a winning combination of numbers, you will qualify for either (i) one (1) winning share in the Jackpot Prize, Prize Group 2, Prize Group 3 or Prize Group 4; or (ii) a prize in Prize Group 5, Prize Group 6 or Prize Group 7.

#### **Illustration:**

You purchase two Ordinary Entry sets of six (6) numbers. Set A consists of "1", "5", "17", "23", "32" and "41". Set B consists of "3", "5", "23", "32", "38" and "41". If the Winning Numbers are "1", "5", "17", "23", "41" and "49" with "32" as the Additional Number, for Set A, you will have one (1) winning share in Prize Group 2 (but not Prize Group 3 or Prize Group 4). For Set B, you will win a prize in Prize Group 6 (but not Prize Group 7).

5.15 If you have placed a System Roll Entry, System 7 Entry, System 8 Entry, System 9 Entry, System 10 Entry, System 11 Entry or System 12 Entry, you are essentially

placing bets on multiple sets of six (6) numbers, as illustrated at Clause 2.5 above. Therefore, your Entry may result in you achieving more than one (1) winning combination of numbers, and you may qualify for (i) one (1) or more winning shares in the Jackpot Prize, Prize Group 2, Prize Group 3 or Prize Group 4; or (ii) one (1) or more prizes in Prize Group 5, Prize Group 6 or Prize Group 7, or both.

#### **Illustration:**

You purchase a System 7 Entry with the numbers "3", "8", "14", "21", "22", "26" and "34", in other words your System 7 Entry contains seven (7) separate sets of six (6) numbers as follows:-

Set A: [3, 8, 14, 21, 22, 26] Set B: [3, 8, 14, 21, 22, 34] Set C: [3, 8, 14, 21, 26, 34] Set D: [3, 8, 14, 22, 26, 34] Set E: [3, 8, 21, 22, 26, 34] Set F: [3, 14, 21, 22, 26, 34] Set G: [8, 14, 21, 22, 26, 34]

If the Winning Numbers are "3", "8", "21", "22", "26" and "39" with "14" as the Additional Number, your winnings will be as follows:

Set A: One (1) winning share in Prize Group 2 Set B: One (1) winning share in Prize Group 4 Set C: One (1) winning share in Prize Group 4 Set D: One (1) winning share in Prize Group 4 Set E: One (1) winning share in Prize Group 3 Set F: One (1) winning share in Prize Group 4 Set G: One (1) winning share in Prize Group 4

Therefore, you will have one (1) winning share in Prize Group 2, one (1) winning share in Prize Group 3 and five (5) winning shares in Prize Group 4.

5.16 The number of such winning shares or prizes that may be won by the different winning combinations of any System Entry is comprehensively set out in the table as follows:-

# 6. Irregularities

6.1 Refunds are not available for any purchases made in respect of the TOTO Game, save that if a force majeure event occurs, we may at our sole and absolute discretion either choose to refund the stake paid, or postpone the relevant TOTO Game draw to a later date in which event no refunds will be given. We will only grant refunds if we are satisfied at our sole and absolute discretion that your claim is valid. Where there is any non-compliance of regulatory requirements in respect of a particular draw, such draw may be postponed but no refunds will be issued.

For purposes of this clause, a force majeure event refers to any event beyond the reasonable control of Singapore Pools, including but not limited to strikes and labour disputes, accidents, war, invasion, riot, rebellion, civil commotion, insurrection, fire, flood, high winds, lightning, changes in law, national or state emergencies or other governmental actions, epidemic, disease, explosion, act of God or embargoes.

- Where there is evidence of any rigging of any draw which is the subject of any bet placed with Singapore Pools, we reserve the right to do any or all of the following:
  - a) Delay the announcement of the results of the affected draws,
  - b) Withhold payment of the relevant prizes pending the outcome of any investigation into the suspected rigging.
  - c) Withhold payment of the relevant prizes pending verification of the suspected rigging.
  - d) Declare bets on the relevant draw as void. In such an event, all bets for the relevant draw will be refunded.
- 6.3 If a fault or failure occurs in the equipment used for a draw in the course of the draw, Singapore Pools shall have absolute discretion to determine the validity of the draw. For instance, Singapore Pools may declare that any and all numbers that have been drawn were duly and validly drawn, or declare that the draw is void and commence a new draw whether using the same equipment or otherwise. If a draw has been declared to be void by Singapore Pools, this draw shall be treated as if it has never taken place, and all bets shall be refunded.
- 6.4 Where any error or miscalculation of any prize is discovered at any time, Singapore Pools shall be empowered at our sole and absolute discretion to declare a revised prize.
- 6.5 Where a revised prize is declared by Singapore Pools in respect of your winning lottery ticket:
  - a) If you have not previously been paid a prize in respect of your winning lottery ticket, you shall be paid the full revised prize.
  - b) Where you have been paid the original prize and the revised prize is higher in value than the original prize, you shall be entitled to claim the difference

between the original prize and the revised prize, subject to any reasonable conditions of payment which Singapore Pools may impose at our sole and absolute discretion.

- c) If you have failed to present yourself for the collection of the revised prize or the difference between the original prize and the revised prize by the expiration of the time specified by Singapore Pools as stated on the Singapore Pools website and mobile app for the payment of the revised prize, or otherwise failed to adequately identify yourself to our satisfaction or to accept our conditions of payment (if any), the unclaimed revised prize or difference shall be forfeited.
- d) Where you have been paid the original prize and the revised prize is lower in value than the original prize, Singapore Pools shall be entitled to recover the difference from you.

#### 7. General Provisions

- 7.1 These TOTO Game Rules shall apply to TOTO Game Draw No. 4086/2025 and all subsequent TOTO Game draws where Singapore Pools (or our agent or a third party nominated, selected or appointed by us) draws the Winning Numbers for a draw.
- 7.2 By placing a bet for the TOTO Game, you agree to be bound by these TOTO Game Rules.
